
Early Retirement Option Deadline Is Friday, April 15

Measure M: Measure M passed with more than 70% voter ap-

proval. What does this mean for MUSD? Bond proceeds will contribute at least \$63,000,000 toward projects at the school sites, thus qualifying the district to receive a dollar-per-dollar match from the state. Our critically overcrowded schools, priority school projects, and other district projects will benefit from this passage. As required by the state, the proceeds from the sale of bonds will be used only to acquire or improve real property, and for furnishing and equipping school facilities and not for any other

purpose.

Facilities Update: Pam Johnson gave an update on what is happening throughout the district. LMI is undergoing major construction in compliance with the Americans With Disabilities Act. The LNE roadway has been completed. The CCE site is the next modernization project. Scheduled completion is at the end of March 2005. The BHS project is close to settlement with the insurance company. Bella Vista replaced seven leased bungalows with the district's own.

Budget Status:

Enrollment:

Glenn Sheppard explained the 2002/04 Un-audited Actual Financial Report. Un-appropriated reserves are about \$2,000,000 higher than the June estimate. About \$1,000,000 came from the expenditures transfer to categorical programs. In addition, \$500,000 was re-captured from unused budget in Routine Maintenance. The 2005/06 budget outlook still projects a negative reserve at June 30, 2006. Bo Henke reported the enrollment in the three comprehensive high schools all show substantial increas-

es over projections. The elementary and intermedi-

ate enrollment continues to be below projections.
