Social Networking May Share Too Much Information

Bargaining Unit members are urged to consider anything posted on Facebook, Myspace, Twitter or other social media as "public." Even though you may think what you post on social media sites is "private", it may not be. If investigators (for any type of legal issue including workers compensation or other litigation) can't access the site because of privacy settings, companies may still have to provide confidential information in response to a subpoena. Something to consider as you post.

The Comprehensive Safe School Plan Is Due to District Office March 1

The Comprehensive School Safety Plan is a state initiated requirement that assures that all students have the right to attend campuses that are safe and secure. Action plans include focus on:

- 1) People & Programs
- 2) Physical Environment.

State legislation requires schools to adopt school safety plans by March 1, and further requires that these plans be reviewed by the school site council or school safety committee every year thereafter. The District Comprehensive School Safety Plan Template includes the MTA Site Safety Committee Survey.

Your Signature Verifies Attendance & Enrollment

Teachers are required to sign student attendance sheets. The attendance sheet and your verification is used to audit average daily attendance (ADA). The District is paid by the State based on the ADA in each classroom. Therefore, it is important that you verify accurate information.
