


## CTA Recommends Torlakson for Re-Election Superintendent of Public Instruction

Torlakson began his career as a science teacher in the Mount Diablo Unified

School District (where he remains a teacher on leave) and served in California's state Assembly and Senate before becoming state schools' chief in 2010.

In its quarterly meeting in Los Angeles, CTA's 800-member State Council of Education also voted to support the re-election of Lt. Governor Gavin Newsom; state Attorney General Kamala Harris; Commissioner of Insurance Dave Jones; Controller John Chiang who is a candidate for state Treasurer; and Assembly Speaker John Perez who is running for state Controller.

Yes on 41- The Veterans Housing & Homeless Prevention Bond Act of 2014

This initiative will allow homeless veterans, veterans, and veterans' families who are at risk of homelessness, and veterans struggling with disabilities and unemployment to access safe, decent, affordable places to live, and to access needed mental health, substance use, case management, and job training service.

#### Yes on 42 - The Public Right to Know

This initiative makes access to public meeting and information a right, not a luxury. It protects transparency laws that guard against corruption and mismanagement. And, Proposition 42 establishes open government and transparency laws as core local responsibilities, ensuring taxpayers are no longer required to foot the bill for items local governments have a duty to provide on their own.
