Open enrollment for health insurance closes Friday, October 10. The changes in insurance will begin January 1, 2015. Changes are made through Benefits at the District Office.


Open enrollment is the time to change health insurance carriers and add or delete dependents. If you have no changes, you need not do anything.

Bargaining Unit members with health insurance also are eligible for dental and vision insurance. Bargaining Unit members who have vision coverage within the HMO health plan also have VSP vision insurance.

U.S. and international teachers receive grants to study at university, observe classes and complete a project pertaining to their field of educational inquiry during their time abroad. The program is open to teachers from the U.S. and selected countries in multiple world regions.

ELIGIBILITY & APPLICATION REQUIREMENTS:

- Master's degree or enrolled in a Master's program (U.S. teachers only)
- Full time K-12 teaching position, including classroom teachers, guidance counselors, curriculum coordinators, Special Education coordinators, media specialists/ librarians and talented and gifted coordinators
- Spend at least 50% of time interacting with students
- Five years of full time teaching experience
- Proven track record of professional development activities and leadership
- Other requirements as indicated on the website
