# District Will Generate Class Size Stipends No More Forms to Fill Out

The new contract language requires the District <u>not</u> the teacher to initiate the class size overage stipend. The language is as follows:

The District shall be responsible for notifying the Bargaining Unit member of stipend eligibility prior to the end of the semester.

The District has committed to honoring the above language this semester (2018-2019 second semester.) This is a transitional semester. Thus it is anticipated that some teachers may have already submitted the form and/or still plan to submit. No harm will come from submitting the form this semester.

The Contract also continues to state:

The Board and the Association believe that the goal of the District is to program a reasonable number of students into each class. Oversize classes are a detriment to learning and should be avoided whenever possible. The purpose of this provision is to ensure the best interest of the education program. The provision should not be used to supplant the employment of Bargaining Unit members. The District and the Association acknowledge that the following provisions should not alter the appropriate staffing for the above class size limits.

### Information on Class Size Overage Stipends

Class Size stipends are paid when Administration exceeds class sizes listed in the contract.

- 1. The stipend shall be paid no later than 30 calendar days after the end of the semester.
- 2. The District is responsible for notifying the teacher of eligibility.
- 3. In no case shall a Bargaining Unit member receive more than \$700 in one semester.
