# Montebello Unified School District Resolution No. 39(2019-2020) Recognizing the Contributions of Underrepresented Minorities in Montebello Unified School District

**WHEREAS**, the Montebello Unified School District has been a champion of comprehensive and quality education; and

**WHEREAS,** building an educated society requires eradicating a non-inclusive version of American history; and

**WHEREAS**, current standards for teaching history come from a Eurocentric perspective; and WHEREAS, not learning about the comprehensive history and contributions of people of color in America contributes to lower test scores and achievement gaps for African American, Latinx/ Chicanx, and Native American students; and

WHEREAS, the current study of African American history, Asian American history, Latinx/ Chicanx history. Armenian history, and Native American history across the United Stales lacks concepts and the analysis critical to a basic understanding of the history of ethnic minorities in the United States; and WHEREAS, through a resolution adopted in 2015 (Resolution No. 15 (2014-2015)) the Montebello Unified School District has demonstrated its unwavering support for the inclusion of the voices and histories of underrepresented minorities and diverse curriculums in the Ethnic Studies program; and WHEREAS, the history of African Americans, Asian Americans, LatinxlChicanx, Armenians, Native Americans, and other groups represented in the Montebello Unified School District community should be a part of the curriculum in elementary seho&s, intermediate schools, and lugh schools, and this curriculum should be reviewed by recognized scholars of Ethnic Studies; and

**THEREFORE BE IT RESOL VED**, that the Montebello Unified School District empowers students to achieve academic excellence as model citizens by reaffirming the Ethnic Studies Resolution No. 15(2014- 2015) stating that, "The Montebello Unified School District seeks to provide a well-rounded, quality educational curriculum that exposes students to cultures that are crucial to understanding our community. nation. and world, past and present, and that helps our students appreciate the rich histories and cultural contributions of their own communities;" and

**BE IT FURTHER RESOLVED**, that Montebello Unified School District shall renew its pursuit of a diverse curriculum in Ethnic Studies and History by engaging school and district personnel, students, and parents and community members.

**BE IT FURTHER RESOLVED**, that the Montebello Unified School District shall continue to provide professional learning opportunities to all personnel and educational opportunities to families on ethnocentrism, racism, and other forms of prejudice and bias that affect underrepresented minorities. 444 BE IT FINALLY RESOL VED, that the Montebello Unified School District adopts Resolution No. 39(2019- 2020) on this 3rd day of June 2020.
