The results of the *MTA Additional Instructional Days Survey* were overwhelmingly in support of Monday, June 13, Tuesday June 14, and Wednesday, June 15. The days for grades TK-12 will follow the original end of the school year (Friday, June 10). Summer school will begin the week of June 20. **Head Start received a waiver and need** <u>not</u> make up the days.

- The rate of pay will be per diem per hour.
