Student Loan Debt Relief Applications Due 12.31.22

On Aug. 24, 2022, the Biden-Harris Administration announced a <u>Student Debt Relief Plan</u> that includes one-time student loan debt relief targeted to low- and middle-income families. The U.S. Department of Education (ED) will provide **up to \$20,000 in debt relief to Federal Pell Grant recipients and up to \$10,000 in debt relief to non-Pell Grant recipients.** Borrowers with loans held by ED are eligible for this relief if their individual income is less than \$125,000 (or \$250,000 for households).

You're eligible for student loan debt relief if your annual federal income was below \$125,000 (individual or married, filing separately) or \$250,000 (married, filing jointly or head of household) in 2020 or 2021.

- **\$20,000 in debt relief:** If you received a Pell Grant in college and meet the income threshold, you'll be eligible for up to \$20,000 in debt relief.
- **\$10,000 in debt relief**: If you did not receive a Pell Grant in college and meet the income threshold, you'll be eligible for up to \$10,000 in debt relief.

Here's what you can do to get ready and to make sure you get our updates:

Log in to your account on StudentAid.gov and make sure your contact info is up to date. You will be sent updates by both email and text message, so make sure to <u>sign up to receive text alerts</u>. If it's been a while since you've logged in, or you can't remember if you have an account username and password (FSA ID), we offer <u>tips to help</u> <u>you access your account</u>.

If you don't have a StudentAid.gov account (FSA ID), you should <u>create an account</u> to help you manage your loans. Make sure your loan servicer has your most current contact information so they can reach you. If you don't know who your servicer is, you can <u>log in</u> and see your servicer(s) in your account dashboard.

The application will be available online in October 2022.Updates are posted on StudentAid.gov.

Register and indicate that you want an email sent to you when the application is available. You'll have until Dec. 31, 2022, to submit your application.

Mask Wearing Rules & Recommendations for LA County While Los Angeles County remains in the Low CDC COVID-19 community level, masks are still required in some settings and strongly recommended in others.

You must wear a mask in:

- Healthcare settings
- Congregate care facilities, such as long-term care settings and adult/senior care facilities
- In any other location where it is required by the business or venue
- If you have COVID-19. You must wear a highly protective mask (even at home) when you are around others until you end isolation. If you are eligible to end isolation after Day 5 because you have a negative test result, it is strongly recommended that you continue to wear a mask through Day 10. In workplace settings, you must wear a mask through Day 10.
- If you are a close contact to someone with COVID-19. You must wear a highly protective mask when you are around others indoors for 10 days after your last day of exposure.
- If there has been a recent outbreak at your workplace or the congregate setting where you live.

Masking is an individual preference in the following settings:

- In state and local correctional facilities and detention centers
- Homeless and emergency shelters
- In all other indoor public settings, businesses, government offices, childcare, TK-12 schools, and higher education settings.

Indoor mask wearing rules and recommendations in Los Angeles County change based on federal, state, and county requirements and the LA County CDC COVID-19 community level and transmission rate.
